Invitation for Bids for the **Construction of HurhureKhola RCC Bridge**
Location: Yangsila Okhre Road, Kerabari Rural Municipality-05, Aaptaar Morang

- The Kerabari Rural Municipality, Kerabari, Morang *has allocated funds or received a grant* from **Government of Nepal (GoN)** towards the cost of **Construction of HurhureKhola RCC Bridge** and intends to apply part of the funds to cover eligible payments under the Contract **for Construction of HurhureKhola RCC Bridge/KRMC/MOR/FE/NCB-01(075/76)**. Bidding is open to all eligible as per Section V of bidding document. The Kerabari Rural Municipality, Kerabari, Morang invites electronic bids only from eligible bidders for the **Construction of HurhureKhola RCC Bridge** under National Competitive Bidding Single Stage Two Envelope Bidding procedures. Only eligible bidders with the following key qualifications should participate in this bidding:
 - Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: **NRs.(3,50,00,000.00)**
 - Minimum Work experience of similar size and nature: **2 contracts of bridge construction work within last 10 years with contract value not less than contract amount NRs. (3,00,00,000.00)**
- Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid through electronically bidding process only as per the provision of the Bidding Document.

Bidder who submit their bid electronically may purchase the hard copy of the bidding documents may download the bidding documents for e-submission from PPMO's e-GP system www.bolpatra.gov.np/egp. Bidders, submitting their bid electronically, should deposit the cost of bidding document in the Project's Rajaswa (revenue) account as specified below .**

- Pre-bid meeting shall be held at **Kerabari Rural Municipality Office** at 14:00 hrs on 2075.07.08 (**25 October 2018**)
- Electronic bids must be submitted to the office of the **Kerabari Rural Municipality, Kerabari, Morang** through PPMO's e-GP system **www.bolpatra.gov.np/egp** or before **12.00 PM** on **2075/07/26 (12 November 2018)**. Bids received after this deadline will be rejected. The bids will be opened in the presence of Bidders' representatives who choose to attend at **2075/07/26 (12 November 2018) 14:00 PM** at the office of **Kerabari Rural Municipality, Kerabari, Morang**. Bids must be valid for a period of **90.00 days** after bid opening and must be accompanied by a bid security **or scanned copy of the bid security in pdf format in e-bid**, amounting to a minimum of **NRs. 17,50,000.00**, which shall be valid for 30 days beyond the validity period of the bid.
- If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
