- 1. Kerabari Rural Municipality has allocated funds towards the cost of Construction Of Rural Municipal Executive Office Building, Kerabari Rural Municipality and intends to apply part of the funds to cover eligible payments under the Contract for Construction Of Rural Municipal Executive Office Building, Kerabari Rural Municipality, Contract ID: KRMC/MOR/W/NCB-01(077/078). Bidding is open to all eligible as per Section V of bidding document.
- 2. **Kerabari Rural Municipality** invite electronic bids from eligible bidders for **the Construction of Rural Municipal Executive Office Building, Kerabari Rural Municipality** under National Competitive Bidding Single Stage Two Envelope Bidding procedures.

Only eligible bidders with the following key qualifications should participate in this bidding:

- Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: [NRs 4,30,00,000 excluding VAT]
- Minimum Work experience of similar size and nature: [at least 2 Contracts within the last ten (10) years, each with a value of at least NRs 4,55,00,000 excluding VAT]
- 3. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit their bid electronically as per the provision of ITB 21 (b) of the Bidding Document.

Bidder who chooses to submit their bid electronically may purchase the hard copy of the bidding documents as mentioned above or may download the bidding documents for e-submission from PPMO's e-GP system www.bolpatra.gov.np/egp. Bidders, submitting their bid electronically, should deposit the cost of bidding document along with the copy of company/firm registration certificate, and upon payment of a non-refundable fee of Nrs 5000 till 3rd DEC, 2020 during office hours in the Project's Rajaswa (revenue) account as specified below.

- 6. Pre-bid meeting shall be held at **Kerabari Rural Municipality**, **Kerabari**, **Morang** at **22nd NOV**, **2020 at 1:00 PM**.
- 7. Electronic bids must be submitted through PPMO's e-GP system www.bolpatra.gov.np/egp before **12:00 PM** on **4th DEC**, **2020**. Bids received after this deadline will be rejected.
- 8. The bids will be opened in the presence of Bidders' representatives who choose to attend at 1:00 PM on 4th DEC, 2020 at the office of Kerabari Rural Municipality. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of NRs 19,20,000. which shall be valid for 30 days beyond the validity period of the bid.
- 9. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
